SECOND AMENDMENT TO DECLARATION AND
GENERAL PROTECTIVE COVENANTS FOR PELICAN'S NEST

AMENDMENT, made this 27th day of April, 1990, by Westinghouse Communities of Naples, Inc., a Florida corporation, (hereinafter referred to as "Declarant").

W I T N E S S E T H:

WHEREAS, Declarant has recorded that certain Declaration and General Protective Covenants For Pelican's Nest (hereinafter referred to as "Declaration") dated November 17, 1988, in Official Records Book 2030, Pages 663-713, inclusive, of the Public Records of Lee County, Florida which imposes certain protective covenants, conditions and restrictions upon the real property described in Exhibit "A" attached hereto ("Property"); and

WHEREAS, Declarant has recorded an Amendment to Declaration and General Protective Covenants for Pelican's Nest, dated December 6, 1989, in Official Records Book 2113, Page 2958, of said records, which deals with the creation of a community development district for the Property; and

WHEREAS, Declarant has changed the name of the Property from Pelican's Nest to Pelican Landing and desires to additionally hereby amend the Declaration for that purpose.

NOW THEREFORE, in consideration of these premises and the covenants herein contained, DECLARANT hereby amends the Declaration by deleting any and all reference to the name Pelican's Nest and replacing it with Pelican Landing and by deleting any and all reference to the name PN and replacing it with PL. This amendment shall run with the land and be by all parties having any right, title or interest in the Property or any part thereof, their successors and assigns, and shall inure to the benefit of each owner thereof.

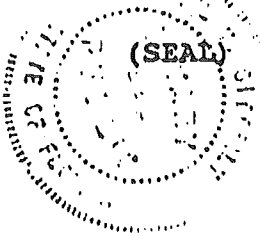
