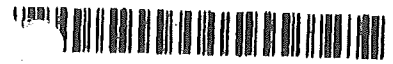

FIRST AMENDMENT TO
THIRTY-THIRD SUPPLEMENT TO
AMENDED AND RESTATED DECLARATION
AND GENERAL PROTECTIVE COVENANTS
FOR PELICAN LANDING
(PARCEL 1)

THIS FIRST AMENDMENT TO THIRTY-THIRD SUPPLEMENT TO AMENDED AND RESTATED DECLARATION AND GENERAL PROTECTIVE COVENANTS FOR PELICAN LANDING is made effective this 23 day of OCTOBER 2003 ("Amendment"), by WCI COMMUNITIES, INC., a Delaware corporation, successor by merger of WCI Communities Limited Partnership, successor by merger of Pelican Landing Communities, Inc. ("Declarant"), joined by ORIOLE OF NAPLES, INC., a Florida corporation ("Developer"), and PELICAN LANDING COMMUNITY ASSOCIATION, INC., a Florida not-for-profit corporation ("PLCA").

WHEREAS, the Declarant has heretofore made, executed and recorded that certain Thirty-Third Supplement, dated March 15, 1995, and recorded in O.R. Book 2585, Page 219, of the Public Records of Collier County, Florida (the "33rd Supplement").

WHEREAS, the intent of the 33rd Supplement was to subject the lands described therein (the "Neighborhood") to the provisions of that certain Amended and Restated Declaration and General Protective Covenants for Pelican Landing, recorded in O.R. Book 2198, Page 1873, of the Public Records of Lee County, Florida (the "Declaration"), and to assign a certain number of Units to the Neighborhood pursuant to Article 1, Section 34 of the Declaration.

WHEREAS, Declarant, Developer and PLCA desire to revise the amount of Units (as defined in the Declaration) attributed to the Neighborhood to reflect the actual number of Units constructed or to be constructed in the Neighborhood.

NOW THEREFORE, in consideration of the foregoing, the Declarant, joined by the Developer and PLCA, hereby amends the 33rd Supplement as follows:

1. Article III, Section 1. PROPERTY UNITS is hereby deleted in its entirety and replaced by a new paragraph to read as follows:
 - "1. PROPERTY UNITS. In accordance with Article 1, Section 34 of the Declaration, Declarant hereby assigns forty-eight (48) Units to the Neighborhood based on the total number of Units shown on the site plan for the Neighborhood approved by the appropriate governmental authorities."
2. Except as modified by this Amendment, the 32nd Supplement remains in full force and effect and is hereby ratified and reconfirmed.

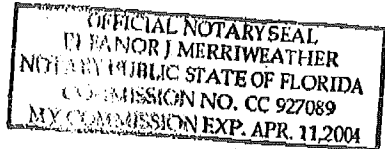
